# Keynote Speaker: Ambassador Craig Allen



The Honorable Craig Allen is the president of the U.S.-China Business Council, a private, nonpartisan, nonprofit organization which represents over 270 American companies conducting business with and in the People's Republic of China. Prior to assuming presidency of the USCBC in July 2018, he served the United States government for almost 40 years, with his career in public service beginning in 1985 at the Department of Commerce's International Trade Administration (ITA). He has since served in Taipei, Beijing, and Tokyo, and was promoted to the Senior Foreign Service in 1999. Besides his work abroad, he also served with the National Center for APEC in Seattle, where he contributed to the success of Asian-Pacific Economic Cooperation Summits (APEC) in Brunei, China, and Mexico. Most recently, he occupied the post of U.S. Ambassador to Brunei-Darussalam from 2014-2018, until transitioning to his current role as USCBC's sitting president. He holds a B.A. in Political Science and Asian Studies from the University of Michigan and a Master of Science in Foreign Service from Georgetown University.

## Feedback and DEI Information

&MUN is committed to creating a safe and inclusive environment for everyone in our conference community. We have coordinated comprehensive policies to ensure the smooth functioning of our conference, but we understand concerns may arise throughout the weekend. Please use the linked forms to provide feedback on committee, conference, and any DEI concerns.

General Feedback Form: This form is for all non-urgent, non-diversity, equity, and inclusion (DEI) conference feedback. This may include committee concerns like parliamentary procedure, unclear logistics, or other comments about the conference. All questions are optional, but please provide as much information as possible so we can adequately address the issue.

Anonymous DEI Form: This anonymous form is for DEI concerns only. This form can address DEI issues that occur in and out of committee and is only accessible by &MUN Secretary-General Andrew Herrup, IRC President Nica Tran, and &MUN Director of Registration and IRC Director of Legal Compliance Peter Awabdeh. All questions are optional, but more information will allow us to address the issue easier.

Additionally, &MUN acknowledges and pays respect to:

"The Indigenous peoples who are the original inhabitants of the land we are on today, the Cheroenhaka (Nottoway), Chickahominy, Eastern Chickahominy, Mattaponi, Monacan, Nansemond, Nottoway, Pamunkey, Patawomeck, Upper Mattaponi, and Rappahannock tribes, and pay our respect to their tribal members past and present."

&MUN stands against William & Mary's history of injustice against marginalized people and its relation to oppressive systems like white supremacy, misogyny, homophobia, transphobia, ableism, economic inequality, colonialism, and imperialism.

## &MUN XII Code of Conduct

As a matter of upholding the decorum and professionalism of the conference, delegates are expected to adhere to the guidelines explained below in the Code of Conduct.

Please be sure to read this code of conduct, as all delegates will be expected to adhere to it for the duration of the conference. Failure to adhere to the Code of Conduct may result in dismissal from the conference and/or disqualification from conference events or awards.

- 1. Delegates are expected to conduct themselves professionally at all times. Delegates found to be disruptive or over-intoxicated will be asked to leave the conference and will not qualify for awards. &MUN secretariat reserves the right to ask delegates to leave &MUN events if they are too drunk or disallow delegates into &MUN transportation if they are over-intoxicated.
- 2. &MUN has a zero-tolerance policy towards the illegal use of drugs and alcohol. The Commonwealth of Virginia and the College of William & Mary have identical policies regarding the consumption of alcohol by persons under the age of 21: it is strictly prohibited. Any infraction of this drug and alcohol policy will be immediately reported to the Head Delegate of the school and Williamsburg Police.
- 3.&MUN and College Policies prohibit smoking inside all buildings and within 25 feet of any building. Participants are strongly discouraged from smoking at any time during the conference. This policy also applies to vaporizers or e-cigarettes. Please respect the Woodlands smoking policies for individual rooms.
- 4. By signing up to attend &MUN delegates are agreeing to be photographed by &MUN staffers to be used for future &MUN conferences and promotional material. If a delegate would not like pictures of them to be taken and used they can inform the Director of Media of their preference.
- 5. The dress code for delegates is Western business attire. Delegates are expected to dress in an appropriate and professional manner and those not abiding by the dress code may be asked to leave.
- 6. Any form of harassment will not be tolerated and any offenders will be dealt with immediately and strictly. Racism, sexism, or other offenses that hinder the inclusivity of all delegates will not be tolerated. Delegates engaging in any of these activities inside or outside of the committee will be disqualified from awards and reported to their Head Delegate. Any and all bigotry will be brought to the attention of the Under-Secretary-General and significantly impact awards potential, both on the individual and delegation levels.
- 7. Any sort of sexual harassment or violence is prohibited. Any infraction will be brought immediately to the attention of the Head Delegate and any delegates committing these acts to be immediately disqualified from awards and dismissed from &MUN.

- 8. The Secretariat reserves the right to immediately expel delegates from the conference for unacceptable behavior including, but not limited to, vulgar language, suggestive remarks, obscene gestures or body language, violent physical outbursts, inappropriate actions or derogatory comments or notes made either in or out of committee.
- 9. In order to enhance and maintain a productive committee atmosphere, personal communication devices such as cellphones, tablets, and laptops are to be disabled in committee sessions unless otherwise noted in the technology policy. All cell phones should be silent before the start of committee. Electronic devices may be used outside the committee room if necessary. If a delegate has a medical or family emergency and has a reason to receive a call during committee, please inform the committee director before the session begins. The Secretariat will grant exceptions to this policy if informed of any necessary accommodations prior to conference weekend. The dais reserves the right to have committees be paperless and utilize technology.
- 10. Delegates must be mindful of the noise curfew at the Woodlands and remember to be courteous to other guests staying at the hotel who are not affiliated with the conference. After 11:00 PM, there should not be delegates congregating in the halls.
- 11. The Woodlands Hotel and Suites reserves the right to ask delegates to leave the hotel for unacceptable and prohibited behavior. All damages to the hotel are the responsibility of the student and his/her sponsor.
- 12. Delegates are bound at all times to act in accordance with good sportsmanship and in respect for fair play.
- 13. &MUN does not accept any pre-writing of committee materials including but not limited to resolutions, directives, and crisis notes. &MUN will also not tolerate work outside of committee unless at the dais discretion.
- 14. Delegates will be bound by the College of William & Mary Honor Code which reads:
  - a. As a Member of the William & Mary community, I pledge, on my Honor, not to lie, cheat, or steal in either my academic or personal life. I understand that such acts violate the Honor Code and undermine the community of trust of which we are all stewards.
- 15. Delegates are also bound by the policies of their respective schools and sponsors.

# Awards Policy

&MUN will give out both individual and delegation awards at closing ceremonies. Committee directors will determine individual awards, while delegation awards will be calculated from the number of individual awards a team has earned. In IRC@W&M tradition, awards will be given to those that the &MUN staff believes to best reflect values of diplomacy, hard work, and compromise.

Delegates and delegations will be asked to abide by both the William & Mary honor code and &MUN XII's Code of Conduct while at &MUN. The secretariat and directors will not tolerate any forms of racism, sexism, bias, or offenses that hinder the inclusivity and success of all delegates in attendance. Any and all bigotry or disregard and disrespect of others will be brought to the attention of the Under Secretary-General and significantly impact awards potential, both on the individual and delegation levels. All awards are subject to the discretion of the Under Secretary-General.

#### Individual Awards

There are four types of individual awards given at &MUN: Verbal Commendation, Honorable Mention, Outstanding Delegate, and Best Delegate.

All crisis committees will have one Best Delegate award, one Outstanding Delegate award, one Honorable Mention award, and up to two Verbal Commendations.

The United Nations Security Council will reward one Best Delegate award, one Outstanding Delegate award, as well as up to two Honorable Mentions and up to two Verbal Commendations. One of the same award to each member of the double delegate delegation.

The General Assembly will award one Best Delegate, two Outstanding Delegates, two Honorable Mentions, and up to three Verbal Commendations.

The Specialized Agency will award one Best Delegate, one Outstanding Delegate, two Honorable Mentions, and up to three Verbal Commendations.

The Ad Hoc Committee of the Secretary-General will give 3 Best Delegate awards and 3 Verbal Commendations.

In the event that the Directors feel they must award more than the prescribed number of awards, the directors will address the Under Secretary-General directly for consideration.

To be considered for an award, delegates must:

- Be present and active at all committee sessions, excluding emergency situations.
- Abide by all standards of the conference and William & Mary conduct.
- Demonstrate obvious substantive knowledge and innovative thinking in committee and in crisis if applicable.
- Respect the work and ideas of other delegates.
- Work with a diplomatic focus—forging ideas through compromise and collaboration.

#### Delegation Awards

Following the selection of individual awards, the secretariat will calculate delegation awards. The Secretariat will split delegations into two categories: small and large. Small delegations will have 10 or fewer delegates while large delegations will have 11 or more. Delegations must register 6 or more delegates to be considered for a delegation award. In calculating these, Verbal Commendations will count for two points, Honorable Mentions will count for three points, Outstanding Delegates for four points, and Best Delegates for five points. The two delegations with the highest point totals divided by the number of delegation committee assignments within each category will be selected as Outstanding Delegation and Best Delegation, respectively. This means that double delegates in the UNSC will not be disadvantaged in awards. In the case of a tie in delegation points, the delegations will be further reviewed by the Under Secretary-General.

# **Technology Policy**

The Woodlands Conference Center and Hotel has extremely limited internet access, requiring many committees to be technology free. All crisis committees and the Ad-Hoc of the Secretary-General will not permit technology use during committee sessions. Delegates will use the "two-pad" system to write crisis notes, with two notepads and a pen provided to all relevant delegates.

&MUN has acquired an outside WiFi provider to bring internet access to the General Assembly, Specialized Agency, and United Nations Security Council. Delegates in these committees will be allowed to use laptops at appropriate times for committee related activities like writing and note passing. The use of technology will be left to the discretion of the dais.



## Parliamentary Procedure

#### Scope of the Rules

The rules of procedure will govern all debate and discourse in committee sessions, except
where the director of a committee chooses to suspend the rules for efficiency. The rules of
conduct apply to all committee sessions. The dais and Under-Secretary General have
final power within their own committee to rule on motions and to determine procedures
where not covered by the rules.

#### Roll Call

• Each committee session will begin with a roll call. The director will read the positions from a roll, and delegates will announce themselves as "present", or "present and voting." Delegates who do not respond are deemed to be absent.

#### **Motions**

Delegates may "move" or "make a motion" at any time after the end of a caucus when
the director calls for them. A motion may be called to begin an Unmoderated Caucus or
Moderated Caucus, to exhaust a Caucus, to introduce a directive, draft resolution, or
amendment, or to end debate. A motion may also be used to move into voting procedure.
The director may take multiple motions, in which case they will be voted on in order
from most to least disruptive.

#### Moderated Caucuses

Debate will largely take the form of moderated caucuses. Informal bodies begin in a
perpetual moderated caucus, with no topic. To propose a moderated caucus, a delegate
must move for one, specifying its topic, duration, and the time per speaker. The chair will
collect motions and allow the body to vote on them in order from most to least
disruptive. Entering a caucus requires a simple majority vote.

#### **Unmoderated Caucuses**

• Delegates may call for an unmoderated caucus for free-flowing debate, or to allow free caucusing. There is no assigned topic for an unmoderated caucus, and delegates may leave the room. For voting purposes, unmoderated caucuses are always more disruptive than moderated caucuses.

#### **Points**

- A delegate may raise a point at any time during debate, except during other delegates' speeches. Points may be raised as follows:
  - Point of Order: to raise a concern on the execution of parliamentary procedure.
  - Point of Inquiry: to ask the dais a question.
  - Point of Personal Privilege: to make a request on the comfort and ease of debate.
  - Right of Reply: delegates who feel they have been personally defamed may submit a written request to make a public reply to the dais.

#### Other Motions

- Delegates have many other possible motions by which they can conduct debate. All of the following require a simple majority for approval. The following other motions relate to document handling:
  - Motion to Introduce: this will introduce any documents submitted to the chair according to the delegate's wishes.
  - Motion to Amend: delegates may move to amend either a submitted document or an already-stated motion before they enter voting procedures.
  - Motion to Table: removes a document or topic from discussion. To be discussed again, the document must be reintroduced.
  - Motion to Enter Voting Procedure: Described below.
  - Motion to Adjourn: ends a committee session.

#### Voting Procedure

- Votes must be taken on substantive matters and on procedural matters. All members present must vote on procedural matters. Members may abstain from voting during substantive matters, but during substantive votes may not leave or enter the room. A motion generally requires a majority vote to pass. The following instances require a 2/3 majority vote to pass in committee:
  - The passing of a directive that has been declared an important question.
  - Censuring any member of the body.
  - Adding or removing voting rights for any member of the body.

#### General Procedure

• Delegates are expected to conduct themselves professionally at all times. The standard dress at &MUN is Western Business Attire. The language of use is English.

Delegations staying outside of the Woodlands will be responsible for their own transportation. The address is 110 S Henry St, Williamsburg, VA 23185.

\*Delegates must be of legal drinking age and present a valid ID to receive any alcoholic beverage. Both event site bartenders and secretariat members will be checking IDs and reserve the right to refuse service to those underage or those deemed unfit. Please consult the &MUN Code of Conduct for more information.

Additionally, wristbands and drink tickets will be provided for guests who are of legal drinking age. Head delegates are responsible for collecting and distributing drink tickets, and each school is responsible for the security of their delegation. All policies noted above apply.
